Maricar S. Prudente, PhD


Dr. Prudente is currently a Full Professor 10 at the Science Education Department, De La Salle University Manila. She used to be the Chair of the Lasallian Institute for Development and Educational Research (LIDER), the research institute of the College of Education of DLSU. She was the recipient of the 2015 Research Achievement Award given by the National Research Council of the Philippines (NRC) for her significant contribution in the advancement of Science Education in the country. Currently, she sits as chair of the Educational Policies Division of NRCP as member of the council's governing board. To date, Dr. Prudente has accumulated 4,154 citations based in over a hundred research articles and an h-index of 31. For this, Dr. Prudente has been consistently recognized as one of the top scientists in the country.

Prof. Jovito C. Anito, Jr.

Prof. Anito is currently the training director of the A&A Knowledge Base Research Consultancy and Training, Inc., and Asst. Professorial Lecturer of the Science Education Department, De La Salle University. He is an advocate of educational action research, having been in various regions in the country, training basic and higher education teacher-practitioners, how to properly conduct each stage of the action research cycle. He is a regular member of the National Research Council of the Philippines (NRCP), Educational, Governmental, and International Policies division. He has been engaged in various externally-funded research projects under the Lasallian Institute for Development and Educational Research (LIDER), the research institute of the De La Salle University College of Education. Currently, he is a University Research Consultant of the José Rizal University, Mandaluyong City and member of the Editorial board of various journals in the country.

Dr. Aguja is currently the Vice Dean of the Graduate School of the De La Salle Araneta University. Dr. Aguja was the 2016 recipient of the National Achievement Award in Research given by the National Research Council of the Philippines (NRCP). Dr. Aguja has published in several ISI- and Scopus-Indexed journals in the field of horticulture, environmental science, and science education.
