- 1. Pursuant to DepEd Order No. 25 s. 2013 entitled *Guidelines on the Conduct of Career Guidance Week for High School Students*, all secondary schools are enjoined to have a Career Guidance Week within the month of July 2019 and undertake similar activities as indicated in the attached timeline.
- 2. At the end of the Career Guidance Week, the students shall have:
 - (a) acquired information on discovering one's strengths and developing awareness, the qualification standards for some types of career jobs, and informed decisions on career choice:
 - (b) developed awareness and appreciation of the available jobs/choices in the labor market, their needs, interests, aptitudes and inclinations; and
 - (c) experienced careers they are aiming at, matching their interest with the possible career in a given array of choices, and identifying a career fitted to one's interest.
- 3. The participants in the career guidance activities are all high school students from Grades 7 to 12, accompanied by their parents or guardians and other education stakeholders.
- Guidance counselors/coordinators/designates are required to submit Narrative Report on the conduct of Career Guidance Week on or before August 9, 2019.
- Relative to the implementation of Career Guidance Program (CGP), all Grade 10 advisers are reminded to integrate in the First Semester Curriculum Grade 10 CGP Modules 1-3 while Grades 11-12 advisers shall integrate the Grade 11 CGP Modules 1-4 and Grade 12 CGP Modules 1-4 respectively.
- 6. Monitoring of the CGP implementation shall be done at the end of the semester.
- Expenses to be incurred relative to these activities shall be chargeable against school MOOE subject to the usual accounting and auditing rules and regulations.
