## AFFIDAVIT OF EXPLANATION

- I, KRIZLE C. ROSALES, Filipino, of legal age, married and a resident of Door 5, AZ Apartment, Prk. Maligaya, Brgy. San Pablo, Tacurong City, Sultan Kudarat, Philippines, after having been duly sworn to in accordance with law, do hereby depose and say:
  - 1. That I am currently the Administrative Officer II, of New Isabela Central School located at Brgy. New Isabela, Tacurong City;
  - 2. That sometime in January of 2022, I have been entrusted by the Department of Education, thru the City School Division of Tacurong the Fifty (50) Samsung Galaxy Tab A7 Lite / Nine Thousand Five Hundred Ten Pesos and 30/100 (Php9,510.30) each;
  - 3. That the tablets were released to the learner-beneficiaries in February of 2022;
  - 4. That the tablets were then retrieved in July 2022;
  - 5. That when I retrieved the tablets from the advisers of the learner-beneficiaries, I thoroughly checked each box where the items were put. Upon checking, almost were complete except for some that had missing headsets; I then called the attention of the adviser and informed them of the lacking headsets, in which the following days, the advisers provided the headsets;
  - 6. That after checking the completeness of all the tablets, I then put each tablet, together with their accessories, such as: headset and charger in their respective boxes and placed them in a big box and covered it with green cloth and eventually kept it inside the Principal's Office for safekeeping, since my office does not have a door;
  - 7. That I first noticed that the tablets were actually lost on January 23, 2023;



- 8. That on January 23, 2023 the PDO II of LRMDS, Leonora R. Po asked me about utilization of the tablets; in which I informed her that the tablets were kept inside the Principal's Office, but since those tablets needed to be utilized, I immediately checked the tablets in preparation for its release to the learner-beneficiaries;
- 9. That, however, when I checked the tablets for inventory, I was so shocked when I found out that the sixteen (16) tablets were not anymore in their boxes and the two (2) tablets together with their boxes were missing;
- 10. That when I found out about the incident, I immediately informed our principal Bemvie L. Alesna and our principal on that time held an emergency meeting with the utility of the school and the three guards. Our newly installed principal Ma. Meresa F. Bacea of the New Isabela Central Elementary School went to the barangay hall to report the matter to the Barangay Chairman regarding the incident.



- 11. That on February 9, 2023, I, together with our new principal, went to the police station and reported the matter and had the incident recorded in the police blotter about the missing tablets. The Police Officers then advised us to execute an affidavit of loss, in which I immediately complied and submitted to the Police Station and they gave me an extract blotter on February 10, 2023;
- 12. That I really believed that I exerted the necessary diligence in safekeeping the tablets. In fact, after checking the completeness of all the tablets and the accessories, I then put each tablet with their accessories such as headset and charger on their respective boxes and place them on the big box and covered it with green cloth and keep it inside the Principal's Office for safekeeping since my office does not have a door;
- 13. That aside from reporting the matter to the Barangay and Police Officers, as a government employee with accountability;
- 14. That I exerted all my efforts to secure the tablets and I also exerted all my efforts to locate the same;

- That I have also exercised the diligence of a good father of a family in the safekeeping of the above-mentioned tablets;
- 16. That the above-mentioned items were lost due to unforeseen events and without any participation on my part;
- 17. That I execute this joint affidavit to attest to the truth of the above facts and circumstances and to relieve me for any accountabilities and for whatever legal purpose it may serve best.

Ma'am,

This is with regard to the letter, extract blotter and affidavit of loss received by this office on February 13, 2023 concerning the lost eighteen (18) units of Samsung Galaxy Tablet A7 Lite.

Section 2 of PD No. 1445 otherwise known as The State Auditing Code of the Philippines states that "all resources of the government shall be managed, expended or utilized in accordance with law, rules and regulations and safeguarded against loss or wastage through illegal or improper disposition with the view of ensuring economy, efficiency and effectiveness in the operation of the government. Thus, every officer of the government whose duties require or permit the possession or custody of funds and property should adhere to the declared policy of the state.

In the exercise of proper transparency, accountability, responsibility and liability in undertaking the accountable officers' duties and functions and for this office to issue Comments and Recommendations, the Property Custodian shall submit its application for relief with the following supporting documents.

- a. Property loss and its valuation;
- b. Actual date in which the absence was first noted;
- c. Manner of loss;
- d. Efforts to put forth to recover the same;
- e. Provisions made to safeguard the property and details/reasons/manner of storage; and
- f. Date when the loss was reported to the Commission on Audit (COA) and police authorities;

- VI. Copy of acknowledgement receipt of equipment or property lost.

This office may conduct further on-site investigation as deemed necessary.

Note that request for relief from the property accountability may be granted or denied based on the evidences presented.

The enumerated documents shall be submitted to this office on or before February 23, 2023.
