In compliance with DepEd Memorandum OASOPS Number 2023-092 re CONDUCT OF REGULAR SCHOOL VISITS AND SUBMISSION OF DATA ON THE ISSUES AND CONCERNS RAISED AND INTERVENTIONS PROVIDED THEREIN and as reiterated by the DepEd Region XII Memorandum Number QAD-2023-016, this Office directs Education Program Supervisors (EPS) and Cluster Heads (CHs) to conduct regular school visits in their respective cluster and school's assignment.


