REITERATION OF DEPED MEMORANDUM NO. DRRMS-05-2023-004 (RAPID ASSESSMENT OF DAMAGES REPORT USER SIM CARD REGISTRATION)

To: Cluster Heads
Public Elementary and Secondary School heads
All Others Concerned

- 1. This is in reference to DepEd Memorandum No. DRRMS-05-15-2023-004 and Region Memorandum ESSD-2023-052 on the **Rapid Assessment of Damages Report (RADaR)** User Sim Card Registration, and Republic Act No. 11934 otherwise known as the **Subscriber Identity Module (SIM)** Registration Act.
- 2. Anent thereto, the School Governance and Operations Division Social Mobilization and Networking Section (SGOD-SMNS) enjoins all School Disaster Risk Reduction and Management (DRRM) Coordinators to register their SIM cards being used for DRRM Information System (DRRMIS). The SIM cards should be registered before the deadline on **July 25**, **2023**. Failure to register may result in SIM card deactivation which will cause delay in reporting on the RADaR application, hindering critical information and data to be recorded and submitted immediately.
