This has reference to the communication sent by Professional Regulation Commission re request for assistance to disseminate names of LPTs whose CORs are available for release.

The fourteen thousand (14,000+) unclaimed CORs are available at PRC – Koronadal Regional Office and are ready for release.

Concerned LPTs are advised to claim their CORs at PRC-Koronadal Regional Office during office hours and are asked to present the latest passport-sized picture with complete name tag and documentary stamps upon claiming. Moreover, representatives who are holders of valid PRC ID must present authorization letters and valid PRC IDs of both the owner and the representative. Otherwise, a Special Power of Attorney must be presented.

SDO HRMOs are advised to validate the list of names of LPTs through online link https://shorturl.at/ahvET, encourage teaching personnel with CORs to claim, and post the same in their respective bulletin boards for wide dissemination.

This has reference to the Certificates of Registration (COR) of Licensed Professional Teachers (LPT) who had their initial registration at PRC – Koronadal Regional Office, PRC - Robinsons General Santos Service Center and PRC – Kidapawan Service Center several years ago up to 2022. To date, there are more than fourteen thousand (14,000+) unclaimed CORs which are available at PRC – Koronadal Regional Office and are ready for release.

In an effort to reach out to the owners of the CORs, PRC – Koronadal Regional Office posted an advisory on our official Facebook page containing the partial list of names and professions of the owners. The post is continuously updated every week or as necessary. Despite our effort, the turnout was so low that only few professionals were able to claim their CORs.

Relative to this, PRC – Koronadal Regional Office would like to ask for the much-needed assistance of your noble office if you could help disseminate the names of LPTs whose CORs are available for release. We believe that reaching out to the LPTs in the region would be much more convenient for your office considering that a significant percentage of these professionals are working in both public and private schools in the region.

PRC – Koronadal Regional Office will be furnishing you the physical copy of the list of names of LPTs as attachment to this letter. Likewise, we will also send an email containing the link where the soft copy of the list can be viewed online. Should this merit your approval, may we then ask for your official email? Kindly let us know if you also need the physical copies of the lists so we can furnish you the same as soon as possible.

Concerned LPTs shall be advised to claim their CORs at PRC – Koronadal Regional Office during office hours. They will also be asked to present the latest passport-sized picture with complete name tag and documentary stamps upon claiming. Moreover, representatives who are holders of valid PRC ID must present authorization letters and valid PRC IDs of both the owner and the representative. Otherwise, a Special Power of Attorney must be presented.

As we look forward to the favorable response of the Honorable Regional Director, we wish to express our sincere gratitude and appreciation for the kind assistance to this endeavor and for future collaborations.
