ISSUANCE OF LIQUIDATION PRE-AUDIT OBSERVATION MEMORANDUM

To: School Heads School – based Bookkeepers and Disbursing Officers

- 1. The SDO Tacurong City crafted Liquidation Pre -Audit Observation Memorandum "LPOM" form which shall be used to monitor the common errors and lacking supporting documents of Liquidation Reports needed to be improved and complied by the school head and school based finance personnel to prevent future issuances of Notice of Suspension and Notice of Disallowance from Commission on Audit.
- 2. The said form should be attached by the Liquidation in charge as cover page of every Liquidation Reports for compliance by the school.
- 3. The school should comply the observation/s 3 days upon receipt of the communication from the Group Chat "CSDT SB ADAS".
- 4. For the submission of compliance, the school head shall affix his/her signature to the LPOM form. "No signature of School head, no receipt of Liquidation report" shall be strictly observed.
- 5. Attached is the Liquidation Pre- Audit Memorandum (LPOM) Form.
- 6. All division related issuances which are inconsistent with the provisions of this memorandum are hereby repealed and modified.
- 7. This memorandum shall take effect immediately from the date of its issuance.
