2023 YEAR-END PERFORMANCE REVIEW AND RATINGS OF SDO TACURONG CITY

To: Assistant Schools Division Superintendent Functional Division Chiefs All SDO Personnel Concerned

- 1. In adherence to DepEd Order 02 s. 2015, "Guidelines on the Establishment and Implementation of the Results-based Performance Management System (RPMS) in the Department of Education," the Year-End review and rating of the Office Performance Commitment Review Form (OPCRF) and Individual Performance Commitment Review Form (IPCRF) of personnel shall be conducted from **December 18- 28, 2023**.
- 2. The IPCRF and OPCRF shall be accomplished and completed by the rater and the ratee to:
 - a. Reflect actual accomplishments and results;
 - b. Rate each of the objectives;
 - c. Compute for the score per objective;
 - d. Determine the overall rating for accomplishments;
 - e. Reach an agreement; and
 - f. Assess the competencies
- 3. Other specific mechanism for the Review and Rating shall include:
 - a. one-on-one rating
 - b. presentation of documents as Means of Verification (MOVs)
 - c. Performance agreement/ Action Plan (to be submitted on January 5, 2024)
- 4. The rater and ratee shall agree on the specific date, time, and venue for rating. Relative to this, all chiefs and unit heads are advised to rate the recalibrated IPCRF and OPCRF for CY 2023.
- 5. The Performance Management Team shall convene together with the Division Chiefs, Unit and Section Heads for the presentation of performance rating. A five-
