**GUIDELINES ON THE PHOTO AND VIDEO DOCUMENTATION OF THE 2nd
QUARTER NATIONWIDE SIMULTANEOUS EARTHQUAKE DRILL (NSED)**

The following guidelines are set for the photo and video documentation in schools and DepEd offices:

1. Photo and video recordings of the 2nd Quarter NSED may be used in information and communication materials of the Department, as requested.
2. The following scenarios must be included in the documentation of the school:
 - a. Learners, personnel, and/or parents/guardians wearing personal protective equipment such as hard hats.
 - b. Learners, personnel, and/or parents/guardians doing the Duck, Cover, and Hold.
 - c. Conduct of coordination/preparatory meeting.
 - d. Actual conduct of the 2nd Quarter NSED.
3. The recommended minimum specifications are as follows:
 - a. Photo:**
 - i. File Format: JPG or PNG
 - ii. Dimensions: 4:3 ratio or 16:9 ratio
 - iii. Orientation: Landscape
 - b. Video:**
 - i. File Format: MP4 or MOV (with 1080p or 720p resolution)
 - ii. Dimension: 1920px x 1080px (16:9)
 - iii. Orientation: Landscape
