- 1. In relation to the Regional Memorandum ESSD No. 117, s. 2022 entitled "FILARIASIS MASS TREATMENT FOR SCHOOL CHILDREN AND ADOLESCENT THROUGH MASS DRUG ADMINISTRATION (MDA)," the Department of Education-City Schools Division of Tacurong in Partnership with City Health Tacurong will conduct a Deworming Activity in partnership with City Health which will commence on July 29, 2024 to August 30, 2024 to all Kinder to Grade 12 learners.
- 2. The school deworming activity requires **strict compliance of Parent's Consent** hence, the clinic in-charge is enjoined to gather such as well as to ask assistance of the respective Barangay Health Workers during drug administration. School Heads are enjoined to lead the activity and secure consent forms duly signed by the parents/guardians before deworming activity. The consent used on the first dose will serve as their permit on the second dose. Thus, retrieval of consents must be done by the advisers/ clinic in-charge. The deworming tablets are available at the school health section office for distribution.
- 3. It should be emphasized that the **learners had taken their meals prior to the administration**. Clean drinking water should be available per classroom.
- 4. Anent thereto, the undersigned enjoins all schools to continue advocating the advantages of this undertaking to the school community and other stakeholders and to ensure that all identified students shall be dewormed on the scheduled date.
