The Department of Education (DepEd), through the Office of the Undersecretary for Operations, issued the **Memorandum OM-OUOPS-2024-09-04944: FIFTH ADVISORY FOR THE IMPLEMENTATION OF THE SCHOOL-BASED FEEDING PROGRAM(SBFP) SY 2024-2025** which provides that the feeding shall begin simultaneously across all schools from August 19, 2024 until April 15, 2025. Holidays will be included in the counting of feeding days.


