**ORIENTATION ON FOOD SAFETY PROTOCOLS AND NUTRITIONAL STATUS

1. The Department of Education (DepEd), through the Bureau of Learner Support Services- School Health Division (BLSS-SHD), issues this Institution Guidelines on the Implementation of the School-Based Feeding Program (SBFP) in compliance with the provisions of R.A. No. 11037 or the “Masustansyang Pagkain Para sa Batang Pilipino Act”, the primary statutory basis for the implementation of the SBFP. Food safety training and water testing are important during the preparation of food for learners, it ensures that the food handlers and managers understand best practices to maintain safe and hygienic conditions, as well as to improve access to adequate water supply, functional toilets and effective hygiene promotion in schools.
2. In line with this, Schools Division of Tacurong City, School Health and Nutrition Section will conduct the Orientation on Food Safety Protocols and Nutritional Status Assessment of Learners **to all Administrative Officers/Program Development Officer 1 and Clinic in-charge of the 33 public schools** at Angel’s Food and Catering Services, Tacurong City at 8:00 am on August 29-30, 2024. The goal is to increase awareness of the participants on the importance of food safety and other preparations before the conduct of School Based Feeding Program.
3. In view thereof, school heads are enjoined to ensure the attendance of the designated Administrative Officers/ Program Development Officer 1 and Clinic in-charge on the said activity.
4. Widest dissemination of this Memorandum and participation of all concerned are enjoined.
