SUBMISSION OF LEARNERS' NAMES WITH UNREGISTERED BIRTH RECORDS TO LOCAL CRO AND/OR PSA, CONDUCT OF MOBILE REGISTRATION IN SCHOOLS BY LCR AND NATIONAL ID REGISTRATION OF STUDENTS BY PSA

This is in reference to DepEd Regional Memorandum PPRD-2024-064 which is consistent to the Philippine Statistics Authority SOCCSKSARGEN Region Inter-Agency Committee on Civil Registration and Vital Statistics XII Resolution, for ***all schools to submit names of learners to Local Civil Registrar Offices (CRO) and/or Philippine Statistics Authority (PSA) whose birth record is not yet registered.*** Further, this will allow the Local Civil registrar (LCR) to conduct mobile registration in the school campuses, and for the PSA to conduct the National ID Registration of learners, free of charge.

TO LOCAL CRO AND/OR PSA, CONDUCT OF MOBILE REGISTRATION IN
SCHOOLS BY LCR AND NATIONAL ID REGISTRATION OF
STUDENTS BY PSA**


1. This has reference to Philippine Statistics Authority SOCCSKSARGEN Region Inter-Agency Committee on Civil Registration and Vital Statistics (IAC-CRVS) XII Resolution No. 07, s. 2024 titled ***Requesting Department of Education XII to issue Instruction to Teachers or Administrators to Submit Names of Learners to local Civil Registrar Offices (CRO) and/or Philippine Statistics Authority (PSA) whose Birth Record is not yet Registered and Allow the Local Civil Registrars (LCR) to Conduct Mobile Registration in the School Campuses*** and Resolution No. 08, s. 2024 titled ***PSA Conduct of National ID Registration of Students during Enrolment and Onwards in Schools, which was issued on July 1 and July 12, 2024.***
2. Generally, this conduct of National ID Registration in the school campuses aims to realize the following objectives:
 - a. To strengthen partnership between DepEd and PSA in attaining the goal and fulfillment of country's commitment to the CVRS Decade in which the PSA initiated the Birth Registration Assistance Project (BRAP) since 2023;
 - b. To ascertain innovative interventions to implement and facilitate the registration of unregistered births particularly among Indigenous Peoples (IPs), Muslim Filipinos, and the poorest sectors targeting cities and municipalities with low levels of birth registration through mobile registrations and other effective strategies;
 - c. To enhance the efficiency of civil registration services through BRAP and bring these services closer to the constituents, the PSA entered into a memorandum of Agreement with the Local Civil Registrars of SOCCSKSARGEN; and
 - d. To reach the remaining population without birth certificates through massive registration campaign for unregistered children in schools throughout the region.
3. In line with this, all schools are requested to submit names of learners to Local Civil Registrar Offices (CRO) and/or Philippine Statistics Authority (PSA) whose birth record is not yet registered, to allow the Local Civil Registrars (LCR) to conduct mobile registration in the school campuses and for PSA to conduct the

National ID Registration of students during enrolment and onwards in schools.
Mobile Registration by Local Civil Registrars is free of charge.

REQUESTING DEPARTMENT OF EDUCATION XII TO ISSUE INSTRUCTION TO TEACHERS OR ADMINISTRATORS TO SUBMIT NAMES OF LEARNERS TO LOCAL CIVIL REGISTRAR OFFICES (LCRO) AND/OR PHILIPPINE STATISTICS AUTHORITY (PSA) WHOSE BIRTH RECORD IS NOT YET REGISTERED AND ALLOW THE LOCAL CIVIL REGISTRARS (LCR) TO CONDUCT MOBILE REGISTRATION IN THE SCHOOL CAMPUSES

WHEREAS, The PSA as the agency mandated by RA No. 10625 to carry out, enforce and administer civil registration functions in the country, shall lead all relevant activities that seek to: uphold the continuous and compulsory recording of births, deaths, marriages and other acts and events concerning the civil status of persons; enhance awareness on the importance of civil registry documents; and, produce accurate, complete and updated vital statistics;

WHEREAS, Proclamation No. 1106 declaring the years 2015 to 2024 as CRVS Decades enjoins all agencies and instrumentalities of the National Government and local government units, including GOCCs, in consultation with the private sector, development partners and the citizenry to actively support all activities and programs relevant to the "Get every Pinoy and Pinay in the Picture!" initiative;

WHEREAS, Under the initiative's goal of universal registration, by 2024, at least 99.5 percent of all Filipinos should have their births registered with local authorities and be provided with legal documentation through the issuance of birth certificates;

WHEREAS, In attainment of the goal and fulfillment of our country's commitment to the CRVS Decade, the PSA, initiated the Birth Registration Assistance Project (BRAP) since 2023;

WHEREAS, The Birth Registration Assistance Project (BRAP) will be implemented to facilitate the registration of unregistered births particularly among Indigenous Peoples (IPs), Muslim Filipinos, and the poorest sectors. This initiative will target cities and municipalities with low levels of birth registration through mobile registrations and other effective strategies;

WHEREAS, To enhance the efficiency of civil registration services through BRAP and bring these services closer to the constituents, the PSA entered into a Memorandum of Agreement with the Local Civil Registrars of SOCCSKSARGEN;

WHEREAS, the Inter-Agency Committee on Civil Registration and Vital Statistics (IAC-CRVS) XII conducted its 2024 2nd Meeting on 01 July 2024 in Koronadal City via videoconference where students/learners without birth certificate is among the issues raised;

**REQUESTING DEPARTMENT OF EDUCATION XII TO REITERATE
 ISSUANCE OF INSTRUCTION TO ALLOW PSA TO CONDUCT
 NATIONAL ID REGISTRATION OF STUDENTS DURING ENROLMENT
 AND ONWARDS IN SCHOOLS**

WHEREAS, Section 15 of Republic Act (RA) No. 11055 otherwise known as the Philippine Identification System Act, provides that the Philippine Statistics Authority (PSA) shall be the primary implementing agency to carry out the provisions of the Act;

WHEREAS, Section 15 of the Implementing Rules and Regulations (IRR) of RA No. 11055 states that the PSA shall collaborate with local government units (LGUs), other government agencies, and government-owned and controlled corporations (GOCCs) in order to ensure the registration and enrollment of all citizens and resident aliens and the acceptance of the National ID;

WHEREAS, on 29 March 2023, Regional Development Council (RDC) XII passed RDC Resolution No. 60, series of 2023, requesting the Department of Education XII to allow the Philsys registration of Individuals 5-17 years old in various schools in SOCCSKSARGEN region;

WHEREAS, as of 30 June 2024, 84.68 percent or 3.87 million Filipinos out of 4.58 million population in SOCCSKSARGEN had been already registered in the National ID;

WHEREAS, to reach out to the remaining target population, the PSA XII proposes to partner with the Department of Education (DepEd) XII in the conduct of institutional National ID registration, including the issuance of printed ePhilIDs in various schools in the region;

WHEREAS, the support, assistance, and participation of the schools in the region is instrumental to the success of the National ID implementation;

NOW, THEREFORE, on motion of Ms. Ruby Abegail Serrano, of NEDA XII and duly seconded by Ms. Sheena Mae Punzalan, of DILG XII, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, the Department of Education (DepEd) XII is humbly requested to reiterate issuance of instruction all school
