CHANGE OF SCHEDULE IN THE CONDUCT OF BLICS-BASED TECHNICAL ASSISTANCE TO SCHOOLS ON THE OPENING OF SCHOOL YEAR 2024-2025

To: Schools Division Superintendents

- 1. Relative to the conduct of the **Regional BLICs-Based Technical Assistance to Address Identified Issues and Concerns** to all schools that were visited by the Regional Field Technical Assistance Teams (RFTATs) during the opening of classes for SY 2024-2025, all concerned are hereby informed that the follow-up monitoring which was originally scheduled last September 30 October 4, 2024 (RM-FTAD-2024-015) shall be **rescheduled on November 4-8, 2024**.
- 2. The BLICs-based technical assistance shall be considered as a follow-up visit to the schools based on the results and agreements made between the RFTATs and the schools. Moreover, the said activity shall give focus on:
 - a. The use of **Kumustahan** Approach by the RFTATs/DFTATs that emphasizes a personalized and collaborative method of communication and engagements.
 - b. The issuance of DepEd Order 012, s. 2024 or Amendment to DepEd Order No. 10, 2024(Policy Guidelines on the Implementation of the MATATAG Curriculum).
 - c. The issuance of DepEd Memorandum No. 053, s. 2024 or the Implementation Guidelines for DepEd Order No. 005, s. 2024 (Rationalization of Teachers' Workload in Public Schools and Payment of Teaching Overload).
- 3. Meanwhile, SDOs and schools are encouraged to finalize their class programs and workloads of teachers by adopting the implementing guidelines stipulated in DepEd Order No. 012, s. 2024 and DepEd Memorandum No. 053, s. 2024 prior to the conduct of *Kumustahan* or monitoring and TA.
- 4. Expenses incurred in the conduct of the activity shall be charged against local funds subject to usual accounting and auditing procedures and regulations.
