CONDUCT YEAR-END ASSESSMENT, MONITORING, AND EVALUATION OF PHIL-IRI AND CRLA FOR ALL SCHOOL READING COORDINATORS

1. This Office through the Curriculum Implementation Division (CID) shall conduct a Three-Day Year-End Assessment, Monitoring and Evaluation of PHIL-IRI and CRLA in response to the Implementation of the National Learning Recovery Program (NLRP). This aims to close learning gaps and assist K to 12 learners in attaining learning standards. This will be on November 27-29, 2024 at SDO-Tacurong Conference Hall, participants are expected to arrive at the venue at 8:00 a.m. on Day 1.

2. The activity shall be conducted purposely to:

- gather data on the implementation of the school reading program, revisitation of Action Plan, and interventions on NLRP;
- provides technical assistance/needs-based support to schools in addressing literacy gaps;
- harvest BOSY and EOSY assessment results with analysis

3. All school reading coordinators are required to prepare a 10-minute presentation on the following:
