1. The Department of Education (DepEd) is committed to providing inclusive and accessible education to all Filipino learners, particularly Indigenous Peoples (IP) communities, through the Indigenous Peoples Education (IPEd) Program. In line with this commitment, DepEd seeks to strengthen community involvement in the implementation of IPEd within the Alternative Learning System (ALS) to better meet the unique needs of IP learners outside the formal school system.
2. SDO Tacurong City recognizes the need for a structured orientation on the IPEd Program and a collaborative session for formulating a Community Engagement Plan specifically for the ALS program. This engagement plan will guide IP-responsive activities, foster active participation from IP communities, and support IP learners within the ALS framework and this will be conducted on December 6 – 8, 2024 at Camp 1103, Brgy. Kablon, Tupi, South Cotabato.
3. The program aims to:
 - Orient ALS Implementers on the policies and implementation strategies of the IPEd Program;
 - Establish a collaborative platform for interfacing between ALS educators and IP representatives in crafting a Community Engagement Plan;
 - Identify and incorporate culturally relevant approaches that will support ALS learners from IP communities; and
 - Foster stronger partnerships with IP communities, ensuring their active involvement in ALS program delivery.
