1. Pursuant to DM-OUOPS-2024-05-07008 titled **Supplemental Guidelines for the Implementation of DepEd Order No. 40, s. 2012, or the DepEd Child Protection Policy**, the Department of Education SOCCSKSARGEN Region directs the regional office and all division offices to constitute the Child Protection Committee (CPC) to provide management and enabling assistance to all schools within the region.
2. Anent this, the Schools Division Office of Tacurong City Child Protection Committee shall be composed of the following:

3. The Schools Division Office Child Protection Committee (DCPC) shall perform the following functions:
  - a. Monitor learner rights and protection incidents in the schools and provide technical assistance relative to the referral of cases to partner agencies and other related services needed by the learner;
  - b. Provide immediate and appropriate technical assistance to the Child Protection Committee in schools in handling learner disclosures/complaints;

- c. Allocate funds for school-level capability building, advocacy programs, and other related activities from the Maintenance and Other Operating Expenses Fund of the Division and Program Support Funds downloaded from the Central Office;
  - d. Strengthen inter-agency partnerships and collaboration; and
  - e. Perform such other functions, as may be assigned by the Secretary of the Regional Director.
4. The DCPC shall convene when there are severe and complex incidents that require the immediate attention of the Schools Division Superintendent and Regional Director.
5. To ensure a safe and happy learning environment at the school, the DCPC shall plan and implement preventive mechanisms of learner rights and protection incidents, such as but not limited to the following:
- awareness-raising; and
  - capacity-building activities.
6. For the information and strict compliance of all concerned.
7. Immediate and widest dissemination of this Memorandum is desired.
