- 1. - 2.   - d. must be willing to render service beyond regular duties.
  - e. must have obtained a very satisfactory performance rating for the past 2 years.
  - f. must be willing to sign an agreement/undertaking and commit to its provisions.
  - g. must have no pending administrative, civil, or criminal cases.
