- 1. In relation to the Regional Memorandum ESSD No. 117, s. 2022 entitled "FILARIASIS MASS TREATMENT FOR SCHOOL CHILDREN AND ADOLESCENT THROUGH MASS DRUG ADMINISTRATION (MDA)," the Department of Education-Schools Division Office of Tacurong City, in partnership with City Health Tacurong will conduct a First Round Deworming Activity which will commence on July 1,2025 to December 31,2025 and 2nd Round Deworming Activity which will commence on January 5, 2026 to June 30, 2026 to all Kinder to Grade 12 learners.
- 2. The school deworming activity requires strict compliance of Parent's Consent hence, the School Head and Clinic in-charge are requested to gather such as well as to coordinate with the Barangay Nutrition Council during drug administration for assistance. School Heads are enjoined to lead the activity and secure consent forms duly signed by the parents/guardians before deworming activity. The consent used on the first dose will serve as their permit on the second dose. Thus, retrieval of consents must be done by the advisers/ clinic in-charge. The deworming tablets are available at the school health section office for distribution.
- 3. It should be emphasized that the **learners had taken their meals prior to the administration**. Clean drinking water should be available per classroom.
- 4. Anent thereto, the undersigned enjoins all schools to continue advocating the advantages of this undertaking to the school community and other stakeholders and to ensure that all identified students shall be dewormed on the scheduled date.
