SCHOOL-BASED IMMUNIZATION 2025 IMPLEMENTATION

TO: Assistant Schools Division Superintendent Chiefs, Curriculum Implementation and Schools Governance and Operations Divisions Elementary and Secondary School Heads Elementary and Secondary (Public) This Division

- 1. In line with the DepEd Memorandum 128, s 2016, the Department of Health and Department of Education implemented school-based immunization program to address the need to lower the prevalence of vaccine-related preventable diseases.
- 2. This Division, through School Health Section in Partnership with the City Health Tacurong, enjoins all public schools in the implementation of School- Based Immunization this October 2025 and may extend until December 2025, thus will commence this on September 29, 2025, 8:00am at Dr. Manuel Grińo Memorial Central School Gym as the Kick-off activity.
- 3. The activity requires strict compliance of Parent's consent duly signed by the parents/guardians before vaccination day; hence the clinic-in charge is enjoined to gather such, as well to coordinate to the respective Barangay Health Workers for assistance in the needed master list and data of target grade levels- Grade 1 and Grade 4-female only (Elementary) and Grade 7 (Secondary) before the conduct of the activity. School Heads are enjoined to lead the activity and secure consent forms provided by City Health Office. The consent used on the first dose will serve as their permit on the second dose.

SOCCSKSARGEN SCHOOL-BASED IMMUNIZATION 2025 IMPLEMENTATION

To: Schools Division Superintendents All Others Concerned

- 1. In line with DepEd Memorandum 128, s. 2016, the Department of Health and Department of Education implemented school-based immunization program to address the need to lower the prevalence of vaccine-related preventable diseases.
- 2. DepEd as partner agency and member of SOCCSKSARGEN Region Immunization Coalition, in addressing the welfare of Region 12 learners will collaborate with other stakeholders in implementing school-based immunization program for the whole month of October 2025 and may extend until December 2025 as deemed necessary.
- 3. Early implementation, as early as September, is encouraged provided all provisions in this regional memorandum are satisfied.
- 4. School Based Immunization covers Measles-Rubella (MR) and Tetanus-Diphtheria (Td) vaccines for Grade 1 and Grade 7 learners, and Human Papilloma Virus (HPV) vaccine for Grade 4 female learners.
- 5. School Responsibilities:
 - a. Provide list of schedules to Rural Health Unit or vaccination team for school-based immunization with observation of no interruption of classes.
 - b. Provide accurate master lists of learners in Grade 1, 4 (female), and 7 to the assigned vaccinators at least 7 days prior to school vaccination activities.
 - c. Engage Parents Teachers Association (PTA) and school assemblies to secure parental support and address vaccine hesitancy.
 - d. Ensure safe, organized, and learner-friendly venues for immunization activities within school.
 - e. Work closely with Rural and Barangay Health Units to ensure smooth coordination and successful implementation.
 - Teachers-in Charge or School Health Personnel through class adviser will disseminate and collect the consent form prior to administration of vaccine.
 - g. Class adviser shall ensure a copy of Summary Reporting Form every after vaccination and submit to School Division Office – School Health Section or School Health Personnel.
- 6. School Health Personnel Responsibilities:
 - a. Work closely through series of coordination meetings with Rural and Barangay Health Units to ensure smooth coordination and successful implementation.

- b. Give technical assistance to schools in implementing school-based immunization such as but not limited to resource speakership for information, education, and communication.
- c. School Health Personnel may access this link https://tinyurl.com/SBIIECMaterials for IEC materials during speakership/orientation in schools.
- d. Monitor and follow-up school for the schedule of school-based immunization.
- e. Collect Summary Reporting Form and submit to Nurse in charge/SBI coordinator of Schools Division Office School Health Section.
- f. The Nurse in charge/ SBI coordinator of Schools Division Office – School Health Section shall submit the consolidated Summary Reporting Form of Schools Division Office to Regional Office – School Health Section through this link https://tinyurl.com/RXIISBIReports on October 31, 2025.
- g. School health personnel may participate in the following without comprising the Okay sa DepEd Programs and Learners' Health Assessment and Screening:
 - i. Screen immunization records of learners for a missed dose, series of doses, or all vaccines due to learners;
 - ii. Administer vaccines to eligible learners within school premises;
 - Provide follow-up care and additional vaccinations if required;
 and
 - iv. Perform the recording, data collection and validation of the number of immunized target populations during the implementation period.
