# **VOCAL DUET CONTEST**

## Mechanics & Criteria for Judging

## & Mechanics

- 1. One Entry per group.
- 2. Each entry must consist of two (2) singers forming a duet.
- 3. Contestants may perform with live accompaniment, or with a minus-one track.
- 4. Time limit for each performance is one song.
- 5. The song choice must be wholesome, appropriate for general audiences, in any song.
- 6. Contestants must provide their minus-one or accompaniment in advance to the organizers.
- 7. Contestants must be present during the call time and order of performance; absence when called will mean forfeiture of turn.
- 8. Costumes and stage presence are encouraged but should remain decent and appropriate.
- 9. Decisions of the judges are final and irrevocable.

# Criteria for Judging

Vocal Quality / Tonal Quality – 30%

(Clarity, intonation, control, and overall pleasantness of the voice)

Harmony & Blending - 25%

(Synchronization, vocal balance, blending of voices as a duet)

Musicality & Rhythm - 15%

(Tempo, timing, dynamics, and rhythm)

Stage Presence & Showmanship – 15%

(Confidence, expression, rapport, projection, and audience impact)

Overall Performance & Song Interpretation – 15%

(Creativity, emotional delivery, and connection to the piece)

### Mechanics & Program Flow

## Mechanics

- 1. One entry per group.
- 2. Each entry must consist of two (2) participants to represent their group.
- 3. The contest will have three (3) rounds:
  - Easy Round 1 point per correct answer
  - Average Round 3 points per correct answer
  - Difficult Round 5 points per correct answer
- 4. Each round will have a set number of 5 questions.
- 5. A time limit of 10 seconds will be given to answer each question. Answers must be written on the provided answer sheet/board and raised once time is up.
- 6. Only the first answer submitted will be considered final.
- 7. In case of a tie, a tie-breaker round will be held until a winner emerges.
- 8. The team with the highest total score after all rounds will be declared the Champion.
- 9. Decisions of the Quizmaster and Judges are final and irrevocable.
