Food, Venue and Hotel accommodation, supplies and other materials shall be charged to Program Support Funds to Learner Support Program and Learner Rights and Protection downloaded to SDO General Santos City while travel expenses and incidentals of identified participants shall be charged to local funds or School MOOE subject to the usual accounting and auditing rules and regulations.
