1. As mandated in RA 9155, or the Governance on Basic Education Act of 2001, Republic Act 8525, or the Adopt-A-School Act, and to continuously provide equitable resources to the Tacurongnon learners through appropriate engagements, this Office shall conduct the ***Strengthening Partnership Skills through School Needs Data System 2.0 (SNDS 2.0) and Program Implementation Review of Partnership Engagements within Tacurong City***.
