1. In line with the Department of Education's ongoing efforts to strengthen the delivery of quality, relevant, and responsive basic education and as a result of the discussions and recommendations from the Division Program Implementation Review held on January 19, 2026, this Office **reiterates the optimal utilization of the official DepEd Learning Resource Platforms**, specifically the **Schools Division of Tacurong Learning Resources Management System (LRMS) Website** and the **Learning Resources (LR) Portal** as the primary platforms for accessing instructional materials.

2. The **Division LRMS Website** serves as the official repository of quality-assured, contextualized, and locally developed learning resources. All materials uploaded to this platform have undergone the prescribed division-level quality assurance processes, ensuring alignment with the curriculum standards and responsiveness to the local learning context. Teachers are strongly encouraged to prioritize the use of these resources in classroom instruction, remediation, enrichment, and other teaching and learning activities.

Meanwhile, the **Learning Resources (LR) Portal**, managed by the Bureau of Learning Resources (BLR), contains a wide range of nationally developed and curated learning resources intended to support teachers in the delivery of instruction across learning areas and grade levels. These materials can be utilized as supplementary references to enhance teaching strategies and instructional delivery.
