**DIVISION LAUNCHING AND PILOT IMPLEMENTATION OF  
YAKAP-KONSULTA: SCHOOL-BASED MEDICAL MISSION**

1. In line with the Department of Education's commitment to promote the health, safety, and well-being of learners and personnel, this Office, through the School Health & Nutrition Section, hereby announces the launching and pilot implementation of **DEPED SDO TACURONG HEALTH CLINIC YAKAP-KONSULTA PROGRAM**, a school-based medical mission designed to provide accessible primary health services within the school setting which will commence this **January 21, 2025 9:00am to 12:00nn** at **Tacurong Pilot Elementary School Clinic, TPES Compound, City of Tacurong**.
2. The pilot implementation shall be conducted in selected schools of SDO Tacurong City starting this second week of January 2026 to assess operational feasibility, service delivery, and coordination mechanisms prior to division-wide rollout. Results of the pilot implementation shall serve as basis for program enhancement and expansion of the program.
3. The activity aims to enhance the Medical, Dental & Nursing Services (MDNS) subprogram under the Oplan Kalusugan sa DepEd(OKD) Program through provision of enhanced free medical consultation, basic health assessment with vision screening, health education, laboratory services, provision of medicines for treatment and appropriate referral services of identified learners, teaching and non-teaching personnel, in coordination with the division YAKAP-KONSULTA technical working group, Local Health Insurance Office, and partner institutions and diagnostic centers.
4. This initiative is anchored on the following legal bases:
  - a) DepEd Order No. 013, s. 2017 "Omnibus Guidelines on the Implementation of School Health and Nutrition Programs"
  - b) DepEd Order No. 012, s. 2025 or the "Multi-Year Implementing Guidelines on the School Calendar and Activities"

5. The DEPED SDO TACURONG HEALTH CLINIC YAKAP-KONSULTA School-Based Medical Mission (Pilot Implementation) shall be conducted with the following details:

Target Beneficiaries	Learners (Parental consent is required), Teaching & Non-teaching personnel
Persons Involved	School Health & Nutrition Section team and the technical assistants, Technical Working Group, School heads, Learners, OKD/Clinic Coordinator, Parents of minors, Stakeholders

- 5. Participants are directed to bring the following, if available:
  - a. Accomplished **voluntary** parental consent form (for learners below 18 years old)
  - b. School ID / employee ID
  - c. Any previous medical records, laboratory results, or prescriptions (if applicable)
  - d. Filled up PMRF with attachment (MDR / Birth Certificate)
- 6. The registration **shall be voluntarily** done. School heads are directed to ensure the smooth implementation of the pilot activity in their respective schools. Class advisers shall assist in the information dissemination and collection of parental consent forms, while School Health Personnel with Technical Working Group shall oversee the technical, documentation, and reporting aspects of the medical mission.
- 7. Strict compliance with health, safety, child protection, and school protocols including no disruption of classes policy shall be always observed.

**1. Registration & Verification**

- a. Validation of School ID / employee ID
- b. Submission of voluntary parental consent (for minors)
- c. Issuance of Yakap-Konsulta form

**2. Vital Signs & Triage**

- a. Height, weight, BMI
- b. Blood pressure, temperature
- c. Initial assessment and prioritization

**3. Medical Consultation**

- a. Individual consultation by Physician / Nurse / Midwife
- b. Review of complaints and medical history
- c. Assessment and management plan
- d. Ancillary Services (if available)
- e. Basic screening (e.g., blood sugar, vision check)
- f. Dental screening (if possible)

**5. Treatment & Health Education**

- a. Dispensing of prescribed medicines (if available)
- b. Health counseling and preventive education

**6. Referral & Documentation**

- a. Issuance of referral slips (partnered hospital / diagnostics)
- b. Recording for school clinic monitoring and follow-up
