1. With reference to **Regional Memorandum No. ESSD-2026-011** dated on **January 08, 2026**, the Department of Education (DepEd) Central Office is conducting a nationwide collection of Learner Rights and Protection (LRP) data from schools for School Year 2024–2025. This initiative serves as a primary basis for the development of evidence-based interventions, policy formulation, and the strengthening of safeguarding mechanisms to ensure a safe, supportive, and rights-upholding learning environment for all Filipino learners.
2. In line with this mandate, the Tacurong City Division Office, through the Learner Rights and Protection (LRP) Coordinator, shall undertake the **validation of Learner Rights and Protection (LRP) data for SY 2024–2025 (Batch 1)** to ensure that all reported concerns, cases, and incidents are accurate and complete.
3. To ensure confidentiality and data security, the Excel files containing the list of public schools with LRP concerns, cases, or incidents shall be transmitted only through official DepEd email accounts and coordinated directly with the Schools Division Office LRP Coordinator for consolidation.
4. All public-school heads are enjoined to carefully review and verify the accuracy of their respective LRP data. For purposes of data integrity and official endorsement, all validated reports must be duly signed by the Division LRP Coordinator and approved by the Schools Division Superintendent.
5. The validated reports shall be submitted via email to **margareth.lasam@depd.gov.ph** with the subject line: **“SDO\_Validated LRP Data for SY 2024–2025”**,

To: Schools Division Superintendents  
Functional Division Chiefs

1. The Department of Education (DepEd) Central Office is spearheading the nationwide collection of Learner Rights and Protection (LRP) data from schools across all regions for School Year 2024-2025. This initiative is highly significant as the gathered data serve as primary foundation for the development of evidence-based interventions, the formulation of policies, and the strengthening of safeguarding mechanisms. These efforts are essential to ensuring a safe, supportive, and rights-upholding learning environment for every Filipino learner.
2. In line with this mandate, the Regional Learner Rights and Protection endorses the validation of **Learner Rights and Protection (LRP) data for School Year 2024-2025-Batch 1** to guarantee that all reported incidents and concerns are accurately recorded.
3. To maintain the confidentiality and security of sensitive information, the excel files containing the specific lists of schools with LRP Concerns, Cases, or Incidents shall be sent directly to the DepEd email addresses of the respective Schools Division Office LRP Coordinators. The SDOs are expected to immediately act upon these files to support regional data consolidation efforts.
4. To facilitate regional consolidation and timely reporting to the Central Office, all SDOs are directed to review and verify the accuracy of the provided data. For the purpose of data integrity and official endorsement, **all submitted reports must be duly signed by the Division LRP Coordinator and shall be approved by the Schools Division Superintendent (SDS).**
5. The validated reports must be submitted through email at [margareth.lasam@deped.gov.ph](mailto:margareth.lasam@deped.gov.ph) with subject line: SDO\_Validated LRP Data for SY 24-25, and via enclosed hard copy delivered to the Regional Office. The deadline for the submission of validated reports is on **January 30, 2026.**
