**CONDUCT OF THE SUPREME ELEMENTARY LEARNER GOVERNMENT (SELG)
AND SUPREME SECONDARY LEARNER GOVERNMENT (SSLG) ELECTIONS FOR
SCHOOL YEAR 2026-2027**

1. Pursuant to **DepEd Memorandum OUOPS-2025-10-07908**, titled "*Learner Government (LG) Elections for School Year (S.Y.) 2026-2027*", and **Regional Memorandum ESSD-2026-015**, this Office hereby directs all public elementary and secondary schools in the SDO Tacurong City to conduct the **Supreme Elementary Learner Government (SELG)** and **Supreme Secondary Learner Government (SSLG)** elections in accordance with the provisions of **DepEd Order No. 12, s. 2025**.
2. The **school-based SELG and SSLG elections** shall be conducted **immediately after the Third Quarter Examination**, covering a **two-week period** allotted for preparation, campaigning, and voting. Schools shall organize their respective **Commission on Elections and Appointment (COMEAL)** to facilitate and oversee the orderly conduct of the elections.
3. After the completion of school-based elections, another **two (2) weeks** shall be allotted for the conduct of the **District and Division Federation Elections**. These activities shall be spearheaded by the **Division Federation Officers**, with support and technical assistance from the **Division Learner Formation Coordinator** and **Teacher-Advisers**.
4. Pending the release of the revised **Constitution and By-Laws of the Learner Government Program (LGP)**, all schools shall refer to the previously issued guidelines accessible through <https://tinyurl.com/LGP2026-2027>. Schools shall strictly adhere to the prescribed guidelines but may introduce revisions or enhancements through **formal resolutions**, subject to approval, to ensure alignment with the school's unique context and needs.

5. The **Regional Federation Elections** shall be convened after all Divisions have completed their respective **Division Federation Elections**. Participants shall include the duly elected **Division SELG and SSLG Presidents** and **Teacher-Advisers**. Further instructions shall be issued through a separate Regional Memorandum.
6. Anent below is the **Indicative Schedule of Activities** for the Learner Government Elections. All concerned are enjoined to strictly observe the schedule, particularly the **fixed date of the Division Elections**:

Activity	Dates
School-Based Elections	January 26-30; February 2-13, 2026
Division Elections	February 20, 2026
Regional federation Election	March 12-13, 2026

7. Expenses incurred for the **school-based, district, and division elections**, including travel expenses, shall be charged against **school and division MOOE** or other available sources. Expenses for **regional monitoring and the conduct of regional elections** such as food, venue, accommodation, vehicle rental, fuel, tarpaulins, and other incidentals shall be charged against **continuing LSP Program Support funds for Learner Formation** or any other available funds, subject to existing accounting and auditing rules and regulations.

**DEPED SOCCSKSARGEN LEARNER GOVERNMENT ELECTIONS FOR SCHOOL
YEAR 2026-2027**

To: Schools Division Superintendents

1. Pursuant to DepEd Memorandum OUOPS-2025-10-07908, titled **“Learner Government (LG) Elections for School Year (S.Y.) 2026-2027**, all elementary and secondary public schools shall conduct the SELG and SSLG elections in accordance with the provisions of DEPED Order No. 12, s. 2025.
2. The school-based elections for the SELG and SSLG shall be conducted immediately after the 3rd Quarter Examination, covering a two-week period for preparation, campaigning and voting. Schools shall organize their respective Commission on Elections and Appointment (COMEAP) to facilitate and oversee the election process.
3. Following the school -based elections, another two weeks shall be allotted for the conduct of the District and Division Federation elections. These activities shall be spearheaded by the Division Federation Officers through the Support and Technical Assistance of Division Learner Formation Coordinators and Teacher-Advisers.
4. Pending the release of the revised Constitution and By-Laws of the Learner Government Program (LGP), schools shall refer to the previously issued guidelines accessible at <https://tinyurl.com/LGP2026-2027>. Schools shall adhere to the prescribed guidelines but may introduce revisions or enhancements through formal resolutions to align with the unique context and needs of the school.
5. The Regional Federation elections shall be convened once all divisions have completed the SELG and SSLG Division Federation Elections. Participants shall include the elected Division SELG and SSLG presidents and Teacher-Advisers. Further details will be issued through a separate memorandum.

District -Division Elections	February 16-27; March 2-6, 2026
Regional Federation Election	March 12 -13, 2026

7. Expenses for the school-based, district and division elections, including travel, shall be charged against school and division MOOE or other available sources. Expenses for regional monitoring and the conduct of regional elections-such as food, venue, hotel accommodations, vehicle rentals, fuel, tarpaulin, and incidentals- shall be charged against continuing LSP Program Support Funds of Learner Formation or
