1. Pursuant to DepEd Order No. 12, s. 2026 (*Full Implementation of the Strengthened Senior High School Program*) and DepEd Order No. 09, s. 2026 (*Three-Term School Calendar of Activities*), this Office shall conduct a one-day workshop to ensure seamless implementation of the Strengthened Senior High School (SSHS) Program and the imminent learning system policy reforms on May 14, 2026 at the Division Conference Room that will start at 8:00 o'clock in the morning.
2. This activity aims to:
 - a. provide technical assistance to school heads and academic coordinators in the preparation of documentary requirements for the implementation of the Strengthened Senior High School Program;
 - b. deepen understanding of and appreciation for the imminent learning system policy reforms; and
 - c. harmonize class programming and the school calendar of activities into the Three-Term School Calendar of Activities.
3. Participants in this activity shall be the school administrators and academic coordinators from secondary schools offering Senior High School in both public and private, including SKSU, and other elementary and JHS school administrators listed in the attached enclosure.
4. This will be a two-pronged activity. Participants shall be updated on the learning system policy reforms and will clarify any emerging issues and
