CONDUCT OF MANDATORY LEARNERS' HEALTH ASSESSMENT

This Division

1. Pursuant to DepEd Order No. 009, s. 2026, titled *Guidelines on the Implementation of the Three-Term School Calendar in Basic Education*, all learners shall undergo a Mandatory Learners' Health Assessment (MLHA) during the Opening Block and up to three (3) weeks after the opening of classes. This activity shall be conducted by designated school health personnel in coordination with class advisers and school heads.
2. The Mandatory Learners' Health Assessment aims to:
 - a. Conduct general physical examination of learners;
 - b. Perform vision and hearing screening;
 - c. Assess oral health status;
 - d. Determine immunization status;
 - e. Review relevant medical and family health history;
 - f. Identify learners requiring health interventions, referrals, or follow-up care;
 - g. Establish and update learners' health records; and
 - h. Support the overall health, safety, and well-being of learners.
3. School heads shall ensure the full participation of learners and provide the necessary logistical and administrative support for the smooth conduct of the assessment.
4. School clinic coordinator shall consolidate and submit the required reports to the School Health and Nutrition Section every Friday.
5. Attached is the schedule of learner's health assessment in schools for your reference.
