1. With reference to Regional Memorandum NEAP-2026-056, this Office announces the Call for the E-Learning Courses Scholarship Program for DepEd Educators - 2026 Intake 1.
2. This program is open to DepEd teachers and school heads who have submitted a 2025 IPCRF rating. Priority shall be given to educators with at least two years of service. Consideration shall be given to the following groups:
 - a. Teachers I-III requiring interventions;
 - b. Master Teacher I-III requiring intervention;
 - c. High Performing Teachers I-III;
 - d. Head Teachers seeking reclassification to the teaching career track; and
 - e. School heads.
3. Anent this, all Cluster Heads are encouraged to nominate participants based on the criteria mentioned. Further, all data required of the nominees shall be encoded in the 2026 E-Learning Inventory Template via the link <https://tinyurl.com/Elearning2026Nominations> on or before **June 29, 2026**, for the evaluation of the Division Scholarship Committee.
