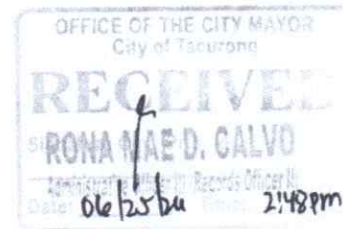

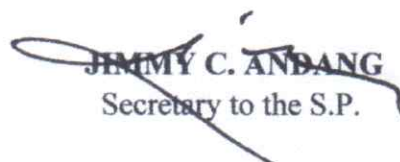

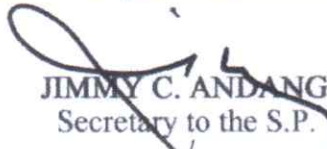
WHEREFORE, on motion of Hon. Jovita M. Duque, and duly seconded by all the members present, it was-
