1. The Department of Education (DepEd), through the Bureau of Learner Support Services–School Health Division (BLSS-SHD), issued **DepEd Order No. 13, s. 2026**, entitled “*Institutional Guidelines on the Implementation of the School-Based Feeding Program (SBFP)*”, which provides the policies, procedures, roles and responsibilities, and other requirements for the effective implementation of the SBFP for School Year 2026–2027.
2. In this connection, the **Schools Division Office of Tacurong City, through the School Health and Nutrition Section**, shall conduct an **Orientation on DepEd Order No. 13, s. 2026** to ensure that School Feeding Coordinators are properly informed and guided on the updated policies, procedures, and implementation requirements of the SBFP.

4. The orientation shall be conducted on **September 1, 2026, at the SDO Conference Hall, Tacurong City**. The participants shall be the **School Feeding Coordinators of all implementing public elementary schools in the Schools Division of Tacurong City**.
